Network Compliance Bulletin No 6

It is some time since Powercor introduced the compliance process for URD projects. It has been pleasing to see with everyone's co-operation that the compliance of projects to the technical standards has shown steady improvement.

With the improvements achieved the majority of remaining non conformances happen around civil issues. With this in mind Powercor is introducing a compulsory staged audit in addition to the existing compulsory Network final Compliance Audit. This new staged audit will need to be completed, signed and submitted prior to the Network final compliance audit. Failure to complete this will result in a major non compliance.

The **Network Staged Compliance Audit Checklist** shall be completed when the cables, including all joints are visible in the open trench. (i.e. prior to any backfilling). The **Checklist** is to be signed by a 'Network Endorsed Auditor' after conducting the inspection and then approved by a second party (Project Manager etc)

A key task included in the staged audit will be the completion of 'As Laid **Details**', as per the Powercor standard for underground cable drawings. Other key items include: *final surface levels* are to be determined and identified, *title pegs* installed and *kerb and channel* completed. It is recommended to use of digital photos to confirm the status at time of the staged audit.

Compulsory **Network Staged Compliance Audits** are to be completed by a **'Network Endorsed Auditor'**, eg. CPLs, PMs, external auditors and Option 2 contractors can qualify after the appropriate training.

Definition of 'Network Endorsed Auditor'

- attended the Powercor Auditor Training course
- completed at least 3 audits with a current Network approved auditor
- be assessed as suitable by the Network Compliance Manager

Those wishing to arrange Network endorsement to complete the compulsory Network Staged Compliance Audit should contact Les Ferris the Powercor Network Compliance Manager on 5327 2404. The use of other staged audits can still be utilised by service providers.

Although the requirement will be phased in over a number of weeks the effective implementation date will be 1 June 2004. In the meantime the existing Network Approved External auditors are able to complete the compulsory staged audit, whilst you arrange your own endorsed auditors.

Network Final Compliance Audits are to be completed by a Network Approved External Auditor (*at this stage*)

Important Changes to Technical Standards

Those with access to the Powercor Technical standards will have been informed of the recent changes to standard GA211 Underground Trenching. The main changes being the depth of HV and LV cables (directly buried with cover slab) is now a minimum 600 mm. Bedding sand thickness has been increase to 100mm below and above the top of the cable.
